If I could describe who Dr. Kirubi was to us in 3 words it would be Father, Mentor & Friend. Dr. CK was a brand to behold. I remember taking pictures with my younger sister in the 1980s at the entrance of International House besides the gigantic concrete flower vessels and my mother, in awe, was explaining to us in Kikuyu “Guku ni kwa Kirubi” meaning this iconic building belongs to Kirubi. That was my introduction to the CK brand that has transcended all generations: from our parents’ oldguards generation to the now youthful tweeter generation. He always used to tell me “you people do not appreciate how big my brand is.”

In the world of business, Dr. CK was the giant on whose shoulders we stood on. He saw the potential in us, he believed in us, he mentored us and proceeded to open doors and platforms that we could only dream about. He had a knack for seeing opportunities where none seemed to exist and when convinced of an idea, he moved into execution mode with obsession. He lived true to the statement “do not do tomorrow what you can do today.” If he caught an idea, and its execution would involve you, he’d call you instantly, even at mid-night. If you worked with CK, you had to be available 24/7/365 days in a year. As he often said “My work is my Holiday,” work gave him a kick.

What we will probably miss most about him is his problem-solving nature. If you ran into a storm, business or personal, one phone call to Dr. CK is all you needed to calm your nerves down knowing that a solution was certainly imminent. I remember many times meeting him in his office and he would be having 5 conversations, all problem solving, at the same time: two on his cell phones, one on his landline, one with his PA standing by his desk and one with me sitting on the visitor’s chair. And he would tell me “Pius, keep talking, I am listening.” He would say “Pius, I have only 24 hours” and is not enough.

To Dr. CK, the distinction between Family and Business was a blurred line. His team was simply part of his extended family. Majority of us have gotten our spouses and children while working for Dr. CK. He has seen our wives pregnant, children birthed, grow and go to schools. To us and our spouses, he has been a Friend and A Father. To our children, he was a grandpa. When my second born son, Lemuel, heard about his demise, he asked “what will happen to his golden sword and the nice cars?” recalling the last visit we paid him at his house.

He used to call me “My Bishop.” We spoke about God and, whilst he had worked very hard for his success, he always acknowledged that God has been instrumental in his life. He felt there was a divine calling to his life -to help people: from supporting his own siblings to the tens of thousands of people that he impacted. He was always amazed by how many people prayed for him. Even in his illness, he understood it was God who was keeping him.

God has surely used Dr. CK to bless many families, including mine. We count ourselves blessed that we did not read about him, but we saw him in real life action, every other day. Working with Dr. CK has been a front row Business and Life Master Class experience.

...I was struck by his resilience



Like many of us, I knew of Chris Kirubi long before I got the opportunity to meet him. I knew of him as flamboyant, wealthy, industrialist, successful businessman and go-getter. I first got to meet him in 2013, when I joined Centum. I confirm that these things I had known of him were true, but also that he was so much more. While I could speak of many, I will speak of just 5 of his attributes:

Firstly, one of the things that struck me back then in 2013 and continued to strike me in every interaction with him since, was just how incredibly intelligent and smart the man was. As he was Chairman of my investment committee, often times we would take to him investment ideas and proposals that we had analyzed for days and had put the entire team to work on. On presenting to him, in an instant, he would point out one or two areas that we had not considered and this would force us back to the drawing board. We have learnt a lot from him in the many years that we got to work together. He left me with the distinct conviction that while one may come across billions of shillings in their life time, it takes brains to remain a billionaire. Secondly, I was struck by his resilience. The investment world is a business of buying the future. There are “known unknowns” and “unknown unknowns”. The world of investing is fraught with challenges. When things were not going according to plan, as they often would not, Chairman was always there to nudge us on and open doors for us, where necessary. One of the many successes we had was in the privatization of KWAL. To date, KWAL is the only company that has been privatized by the Government of Kenya outside of an IPO. This was largely due to Chairman’s push. Another instance was when we were looking to close an acquisition and required Competition Authority of Kenya approval, one December. It was critical to get the approval that December as our exclusivity period with the seller was going to expire. As fate would have it, the Authority’s board meeting got rescheduled to February of the next year. Rather than give up, Chairman placed one call to someone he had never interacted with before. We got our approval that December. Even at a personal level, his valiant 5 year fight against the cancer in his body would not have lasted that long had it not been for his resilience. He fought and fought hard.

Third, was his hunger. With all his fame and success, one would have thought he would sit back, relax and enjoy life, and go at a slower pace. Not Chairman. He must have read The Parable of the Rich Fool (Luke 12:13-21). Chairman looked for opportunities everywhere and did not want to miss a single opportunity. I remember one Saturday afternoon, him frantically placing calls to people at Haco because a salon in town had not received a delivery of some haircare products. That delivery was probably a few hundred shillings in profit, which shouldn’t have disrupted a billionaire’s weekend. But not Chairman. No shilling was to be lost. Even when we closed billion shilling worth of exits of our portfolio companies, the celebration with Chairman lasted a minute or two before we quickly moved on to what was next. Almost every conversation he and I had begun with the question “So, what’s happening?”

Fourth, and this was at a more personal level, the love for his children, Mary-Anne and Robert. The more I interacted with him, he opened up about his journey of fatherhood and how he always sought to get the best for his children as they grew up. One particular example that struck me was when one of them was in high school, and a very good school for that matter, he had noted that they needed extra tuition and he arranged for a private tutor to come home in the evenings. When the tuition was done, Chairman would personally drive the tutor back to his house, some more than 20 kilometers away every night as he had released his driver by the time the tuition was done. Such stories of his sacrifice, have challenged me in my own journey as a father to be available for and make sacrifices for my children. It is clear the sacrifices he made have paid off. Whenever he speaks of his children, as he often does, he does so with great pride and admiration of his children and their successes.

Lastly, Chairman was passionate about everything he did. He often said that if you were not passionate about something you were doing, then you shouldn’t bother at all! He was passionate about each of his businesses and could speak about each at length. He had minute details on each and every of his businesses. It was a fascinating thing for me watching him and listening in on conversations he had with his different business heads every evening that I would get to spend with him. He would question, prod, make suggestions, and paint the big picture at every opportunity with every of his business heads. But it was not just in business that he was passionate. His taste for the finer things in life and wanting nothing but the best stem from this passion. His exquisite car collection is a perfect example. In closing, I convey my sincere condolences to his children, grandchildren and the rest of the family. In his own words, he said he knows that God answers prayer. I therefore pray that our Almighty God may grant you strength, peace and comfort as you mourn your father. I thank the Almighty God for giving us this great man, as I paraphrase from the play, Julius Ceaser, “Here was a great man, when comes such another?!”

I am much honoured to pay tribute to a great son of Rwathia, Murang'a County. It is apt that we should hold this event to celebrate Dr Kirubi's life here on CK Square. CK Square is the magnificent and majestic entrance into one of Africa's largest retail centres. It's a place where Kenyans of all walks of life meet to create their dreams, tell their stories and share fun, warmth and love. The square overlooks the entire development that is the Two Rivers City. From this vantage point, one can see the grand dream of a city taking shape, one tower at a time. And more importantly, a reminder that among us walked a man who decided to build cities from scratch. Across the square, to the East, is the majestic Riverbank Tower. Here, Chairman made his last working visit of Two Rivers and gave his mark of approval for the pioneer residential project on the site, whose design he had initiated.

In many ways, CK Square and indeed the entire development immortalises Dr Kirubi. Not just because he renders his name to the Square and the Eye of Kenya but because it is a physical manifestation of who CK was - a bold visionary who saw what was not there and wondered 'why not?' And from this, what was not there became. Notably, this is the story of CK Square - on an inspection visit to the construction site, he wondered why there shouldn't be a square above what was then an open round-about. And so CK square came to exist. I knew Chairman as a gentleman of great fortitude who saw obstacles to his bold dreams as simple hurdles to jump over, side-step, or crawl under but no matter what, to keep pushing on towards their realisation. This square and the towers surrounding it speak to the other Kirubi we in Real Estate knew - Kirubi the Architect. His passion for design and eye for detail have ensured that all our projects bear his mark - from the detail of interior designs to the exterior look & feel and landscape designs. In his last visit to Pearl Marina, he gave us a lengthy and educative discourse on the Benjamina Ficus trees that were dotting the site and why we should uproot them. He had his own recommendations on how we could green the site better or what colours we could adopt for the Mirabella Villas. Such was CK-not the smallest detail could escape him. A good number of us have spent many hours in his house going through the detail of our designs - I used to advise my colleagues to cancel all other plans when planning such visits. The afternoon would definitely turn into an evening. The evening would turn into dinner.

A lot will be said about this Titan in years to come. But behind the larger-than-life persona lay a most humble man who effortlessly mingled with all, regardless of seniority. He was a man genuinely interested in people. Walking him around this mall was an onerous task of sneaking him away from the crowds that tended to gather around him. Most of us have spent many evenings and weekends in his home and farm - and all you needed was just to turn up, without any formalities. For some of us, his staff had come to know how you like your tea done, testament to a home that had become 'ours' in a way and where we were always welcome.

Shortly after I joined Centum, I requested CK to be the guest of honour in the 2016 Founders Day and Fundraising event at Starehe Boys Center, which he honoured. A year later, I briefed him on a farming program that I was running in Murang'a and which his Murang'a farm supported through a season's crop. Like many of us, CK was not just our anchor shareholder and Chairman, he had become a friend. To us and to our families.

The book of Ecclesiasticus 44 pays tribute to great men and I quote parts of it: Let us now praise famous men, and our fathers in their generations. The Lord apportioned to them great glory, his majesty from the beginning.

Their posterity will continue for ever, and their glory will not be blotted out. Their bodies were buried in peace, and their names live to all generations. Peoples will declare their wisdom, and the congregation proclaims their praise.

I end with that old English quote on turning back to life:

If I should die and leave you here a while, Be not like others sore undone, Who keep long vigil by the silent dust. For my sake turn again to life and smile, Nerving thy heart and trembling hand to do Something to comfort other hearts than thine. Complete these dear unfinished tasks of mine And I perchance may therein comfort you. This is what Chairman would have required of us. Bear with me as I wind the clock back. It is the 1970s. Kenya is in the midst of establishing and cementing its post colonial economic and business structure. It is an age of established business titans still dominating the landscape, with individual clouts larger than what today's corporate moguls wield, notwithstanding the larger resources available to the latter. Bruce McKenzie. Jack Benzimra. Sir Eboo Pirbhai. Jack and Tubby Block. Col David Dobie. Tiny Rowland. Michael Blundell. Sir Ernest Vasey. And many others. Names largely forgotten today, but who in their day moved and shaped the economy, bent it to their will.

But, where are the Africans in this corporate mosaic? To be sure there were Africans holding key economic and business positions. But these weren't capitalists, they didn't dominate the commanding heights of the economy as entrepreneurs and businessmen. Instead they were largely agents and in a real sense creations of the new Kenya State. They ran the big state enterprises, the behemoths that dominated key sectors. East African Power & Lighting. East African Posts & Telecommunications. East African Railways & Harbours. East African Airways. ICDC. Younger readers familiar with the troubles of some of the successor companies to these entities will find it hard to believe that heading these institutions was once the apex of young Africans' corporate ambitions. From these perches they would find their way gradually to private sector corporate Kenya, and along the way hope to build up capital to become modest corporate players in their own right. Likewise ambitious young civil servants served their apprenticeships in government before going off to corporate Kenya. And there were also young Africans getting to the top of private sector corporate giants without being apprenticed in government. Among these Africans then starting to make a mark in corporate Kenya were Joe Wanjui. Udi Gecaga. Ken Matiba. Ngengi Muigai. But they were few, underscoring the painful fact that black Africans were still largely absent from this world. This is the scene that greeted young Chris as he emerged into the business and corporate world, one where Africans, while increasing in number, were still relatively few, and certainly were not yet corporate titans in the sense understood then and now.

I was lucky enough, as a teenager and then as a young adult fascinated by the rapid political, social and business changes Kenya was then undergoing, to have a ringside seat observing the new boys (there were no women in that rarefied corporate world). For reasons that need not concern us here, I got to see Chris and others from quite close range. Remember Chris was walking among giants. He didn't have the family background to be there, and by all rights should have been cowed into timidity by the very frightening men he found himself amongst, men who dominated headlines, ruthless movers and shakers. But he neither quaked nor quailed. Years later, when he and I had become friends in our own right, rather than, in my case, by reason of family, we discussed this phase of his life. His position: he didn't envy or fear these people. Instead he was determined that he was as good as they were, that what he needed to do was learn from them as much as he could. Even at that early stage he was quite clear that he was going places.

And so he went about imbibing business lessons from those who had come before him, including the inevitable intertwining of business and politics. He knew that then as now, managing politics and influencing policy were critical success factors for those aspiring to become the big beasts of capital. But he also learnt from these tycoons not to become overfond of or overwhelmed by politicians, to maintain a close but wary distance from them. And as his career evolved, and as I came to know him more as a person, another side of him gradually emerged. He was, there is no other word for it,

an Africanist in the best meaning of the word. He believed Africans could and must play on the global corporate scene. He couldn't understand the inferiority complexes that permeated so many in positions of power. He empowered young Africans in his businesses, an early indication of his passion for Kenya's youth and their future. He worked hard and played equally hard. He flaunted his success, both because he enjoyed it, and also because he wanted the rest of us to learn to accept and enjoy success. He refused to be caged into a semblance of conventional behaviour. He wasn't a rebel, but he was impatient, willing to stretch the rules of what was deemed acceptable behaviour for people in his position. He was one of a kind, and proud of it

In the 1990s I worked closely with Chris as his banker, then as his investment adviser. I also had a ringside seat as he strove mightily to operationally demerge ICDC Investments from ICDC. This last cemented my respect for his strategic acumen. For many years ICDC Investments, a listed entity in which in that time ICDC held 25% and circa 15,000 Kenyans owned the rest, had been a sleepy appendage of ICDC, its money welcome but its voice unheard. Quite a few investors in London had seen its potential, but a quirk in its charter, which then restricted ownership to Kenya citizens, meant foreigners couldn't mount a takeover. Quite where and how Chris got the idea to give it a go is a story for another day, but in short order he had built up a strong equity position in ICDC Investments, and also succeeded in convincing Government to let the company go its own way, run its own show, with him as controlling shareholder. What made me admire Chris even more was that at about the same time I and other investment bankers had been trying, with little success, to convince moneyed Kenyans to become serious stock market players, including taking controlling positions. Chris did not need us telling him this; he understood it instinctively and went for it. And then he proceeded to make a success of this bold gambit, with ICDC Investments, now renamed Centum, going on to carve quite the swathe in the investment world. And along the way Chris nurtured a new breed of young business leaders. Tony Wainaina. David Owino. James Mworira.

In later years, and while not slackening his business pace, Chris became interested in the forces that drive economies forward. He read widely, attended and kept up with developments at Harvard Business School. He was determined that Africans would find their place in the global corporate sun, and had unbounded faith in the transformative power of business and of the private sector. He was an unabashed capitalist, had little truck with the endless whining about the unfairness of life so beloved of many of us. He detested the corruption that has so permeated our society. My last extended conversation with him, soon after his return from his first round of treatment in the US, was devoted almost entirely to this subject, how we needed to fight corruption. He did not just speak behind closed doors to only a few on this subject. I will never forget a seminal moment in 2015, during a Presidential Roundtable which Chris attended as part of the KEPSA team, when he let rip volubly and relentlessly at a Cabinet Secretary then under sustained media pressure for alleged corruption. This was done in full glare of President Kenyatta, other senior government officials, including said Cabinet Secretary, and a multitude of business people. I like to believe that it was this episode that led to the President appointing, at the end of that Roundtable session, a Government-KEPSA team to come up with anti corruption recommendations.

This was the Chris I wanted to highlight. A smart businessman, yes, But also a nationalist and Pan Africanist. A strategic thinker, much as he tried to hide this side of himself by emphasising and playing up his colourful public persona. A man consumed and driven by his pride in and passion for his people, his unwavering belief that Africans could do it. A man who refused to let the tough cards life had dealt him at birth dominate or determine how his life would unfold. 


